In consideration of the opportunity to participate in or be considered for the above-named Event, I hereby provide Full Sail, Inc. dba Full Sail University, and its agents, licensees, assignees, and other successors-in-interest (collectively, "Full Sail") the following Rights:

1. Full Sail has the exclusive right to film, videotape, photograph, digitally and/or otherwise record Artist's musical, theatrical or other performance (the "Performance") at the Event, including Artist's likeness, voice, appearance, or speech at the Event (the "Photographs and Recordings").
2. Full Sail has the right to use, record, reproduce, publish, display, broadcast and/or exhibit the Photographs and Recordings, as well as Artist's Performance, name, voice, picture, photograph, portrait, silhouette, and/or other reproductions of Artist's likeness, and biographical information about Artist for the following purposes: (a) internally at any school or educational facility operated by Full Sail or in materials or works distributed to students of Full Sail, in any medium now or hereafter known—including via television, broadcast or other media that are distributed internally within any Full Sail school or educational facility; (b) for use worldwide on the Internet or any Internet-based content delivery platform, to advertise or promote Full Sail, its school, and projects, including at Full Sail's web site currently located at www.fullsail.com and for digital download, streaming, podcasting or other Internet-based distribution at any Full Sail Internet web site, web presence or similar means of delivery. Full Sail may edit the Photographs and Recordings, including Artist's appearance, voice and/or performance, as Full Sail sees fit.
3. Full Sail shall have all copyright, title, ownership and interest in the Photographs and Recordings, and any derivative works or uses therefrom. However, Full Sail claims no rights or title to the musical compositions, sound recordings, spoken text or other works performed, used or included by Artist in the Performance.
4. Artist represents it has all rights necessary to perform musical compositions, songs, spoken text or other works during the Performance, and will not violate any copyright laws or infringe upon the rights of any person, firm or corporation in the Performance. Artist warrants that it is responsible and serves as agent for securing all rights necessary for performance of any other artist(s) involved in the Performance. However, Full Sail shall be responsible for securing any and all necessary rights, clearances or permissions for musical compositions, songs, spoken text or other works owned by third-parties, in order to use the Photographs and Recordings pursuant to the rights granted hereunder.
5. The rights granted to Full Sail herein are perpetual, irrevocable and royalty-free (with no compensation due to Artist for use of any rights granted herein). The rights granted by Artist herein are also transferable or assignable by Full Sail to any other person or entity without permission from Artist. However, Full Sail is not obligated to make any use of the Photographs and Recordings, Artist's Performance, name, voice, or likeness, or exercise any rights granted to Full Sail by this Release.
6. Artist expressly releases Full Sail, its agents, employees, licensees and assigns from and against any and all claims which Artist has or may have for invasion of privacy, defamation, violation of any right to publicity, or any other cause of action arising out of production, distribution, duplication, publication, broadcast or exhibition of any advertisements, promotions, content, programs and/or materials in which any portion of the Photograph and

Recordings, Artist's Performance, name, voice, likeness and/or biographical information appears, and/or arising out of Full Sail's exercise of its rights granted herein.

7. This Release shall be governed by the laws of the State of Florida. Any dispute arising out of, or in connection with, this Release shall be litigated in the County of Orange, State of Florida.
8. This consent is given as inducement for Full Sail to have Artist perform at the Event and for Full Sail to potentially use and display Artist's Performance, name, voice and/or likeness for the purposes described above, and Artist understands that Full Sail will incur substantial expense in reliance thereof. Artist has read and understand the meaning of this Release.
